Det. Jacque Wuest (JW) interview with retired Patrolman Edward Angel (Newport PD) (EA) (redacted) September 17^h, 2021 Newport PD. Transcribed by Peter Lance 9.30.21

JW	Its 9.17.2021 and the time is 7:00 PM and I am here with Edward Angel, retired Newport PD. Officer. You're not really ranked when you're retired.
EA	I (inaudible) retire. It was not (inaudible)
JW	OK And it's in regards to Doris Duke. So just for the record could you just state your name and (inaudible)
EA	You Edward E. Angel (spells it out)
JW	And what is your address? (Redacted)
	So I called you to see if you might come in and talk to me about this case. So, to start out with, what do you remember about this?
EA	I remember it was at shift change. I had just arrived and the car the driver that had that car out on The Ocean Drive had just come in. A call came in and I took the car and headed out that way
JW	O.K. You remember about what time that was?
EA	Ah
JW	If you can
EA	It was around five. I think the shift started
JW	Fifty five years ago.
EA	(laughs)
JW	I understand. (laughs)
EA	I think it was somewhere around five o'clock in there Right in that vicinity.
JW	OK.
EA	I got the call and headed that way. When I arrived at the scene, I observed a car across the road on the sidewalk up against a tree.

EA	I got out of my car, approached the vehicle. The driver of the car – who I had no idea who it was – was sitting in the car behind the wheel, bleeding from the – I think the forehead
JW	OK
EA	some facial cuts and she was upset and she was crying, "My friend, my friend I don't know where my friend is
	And I look in the back seat passenger side look around and then I got down on my hands and knees and he was under the car rolled up
	I reached in. There didn't appear to be any signs of life. It's funny, cause there wasn't a lot of blood as I remember it.
	(Exhales) Ah I come up this is where I goofed up. (laughs)
JW	(laughs)
EA	I stood up and I says, rather unprofessionally, "He's under the car," which put her into shock and fortunately there was a woman there who said she had some medical training and I asked her if she could look at the driver of the vehicle.
	Then proceeded with letting the station know what was happening. And after that all sorts of people came. My involvement was primarily to make sure that Doris Duke (who I found out later who that was) that the driver of the car was being taken care of. And then just traffic control because there was nothing to be done that I could do (regarding the victim) who was underneath the
JW	Right.
EA	I think the big discussion now is the statement of that young paperboy that came forward, claiming that when he got by the scene, which – He was no where's there when I got there
JW	Um hm
EA	That she was outside of the car and his statement, whatever it was, indicated that – He also indicated that she wasn't bleeding. And that she tended to want him to shoo him away.
JW	Um hm

So the discrepancy is, I think, is in what I observed and what he reports. Is probably, what's in question and it really depends on whether his statement can be verified or not. I can only say that when I arrived, she was sitting in the car, she was bleeding from the face – I think it was forehead and she was extremely upset.
Of course, I didn't help things by saying, "He's under the car" I was on the job maybe a little over a year
Yeah.
With really no training in that type of an incident
Yeah, yeah
So, to this day I regret that stupid remark.
(laughs)
But anyway that's that's pretty much Then I went on to – I made a diagram of the scene. I had the Point of Impact in the middle of Bellevue Avenue because there was some human residue. I saw skin whatever it washair
So
And I signed off on that the next day (laughs) Sgt. Newton said, "look at this…" I had thought's the gates were open.
Um hm
He pointed out to me that the gates normally open inward and that, his theory was that the driver, who was the victim, had gotten out of the car and was opening the gate when she drove forward and what I had seen in the street is where he had actually come off the hood of the car. And those little scrapes and bits and pieces that I saw, that's what he calculated was.
OK
That's
(papers rustling) So, if we look at here's the drawing that you did.
(takes off his jacket) I'm going to take this off

JW	(laughs)
EA	I thought it was cooler than it is
JW	Do you know if Fred Newton's still alive? ¹
EA	I don't believe so
JW	No?
EA	I know he isn't. I went to his wake.
JW	OK.
EA	The big discrepancy is with the statement the young paperboy did of her being outside the car, uninjured, prior to my arrival on the scene where she was in the car, behind the wheel, bleeding from the forehead.
JW	Um hm
EA	That's the crux of the discrepancy. But Peter (the author) is going after – like a dog after a bone. He's (laughs). My question is, and I told this to Peter, if you listen to the paperboy's statement
JW	Um hm
EA	He was on Bellevue Avenue by Ledge Road when he heard the commotion and it's a long ass way from the gate (the main gate) The entrance. I've walked it, as I'm sure you have many, many times and that's a long way.
	And I told Peter that I found it a little hard to believe that he could have heard that from that distance and I suggested that, why don't we just recreate it. Put somebody over here arguing and you stay down here and start coming this way and see if you could actually hear someone.
JW	Right
EA	Which I thought was a rather simple, common sense way of determining if there was any possibility
JW	Right

¹ Evidence that more than 10 weeks after interviewing Bob Walker, Det. Wuest hadn't even read chapters 32-33 in HOMICIDE AT ROUGH POINT, which notes on page 274 that Fred Newton died in 1999.

EA	That the kid had heard that.
ĽA	
EA	Peter, I don't know if he ever considered that I'm not sure whether he acted on it or not.
JW	Right
EA	But that was the only problem I had with it. Other than that, if the kid's telling – if the young man is telling this story as he remembered it, that's not for me to determine. I can only say that if she was in the car, bleeding from the forehead when I got there, which was not too long after the incident occurred. The (station) then was on Marlborough Street – no the station back then was on Market Square.

EA	But anyway that distance didn't take that long I could have happened as he (Bob) said and if it did, then there's reason to investigate it, not from a prosecution
JW	No. It's just you know information came forward and I'm just looking into it.

EA	I did a little drawing. I'm not sure if it even still exists I had to sign off on it the next day because Sgt. Newton pointed out to me the actual, the physical positions at that time

EA	the gate opening being forced through there was a stop there to stop them from opening out into the street and the action pushed right through that, which I observed
JW	(laughs) (she continues paging through some kind of file)

	ADDITION TO REFORT OF OFFICER EDWARD ANGEL October 21, 1966
	In my report of 5:07 p.m., October 7, 1966, Complaint number $D-4848$, I made the statement as follows:
	"Point of impact appeared to be approximately twelve feet (12!) west of the gate at the estate"
	At that time I was unaware that the gate on the east side of the road at the Doris Duke Estate had been struk and I assumed from scuff marks that I observed twelve feet from the entrance to the Duke Estate was the point of impac.
	This was my first investigation of a major accident and in reviewing the report of Sgt. Newton I found this statement, " Poiht of impact appeared to be twelve feet (12')" was incorrect.
	I was remis in not correct it but I did intend to correct this I returned to the scene of the accident with the officers from the Registry of Motor Vehicles and at that time I looked at the iron gate a little closer and noticed that it had been struc- from the inside and forced open and there had been a collision and that this was the point of impact.
EA	Yeah, that's exactly it. If you read that it's just as I explained the incident to you.
JW	OK.
EA	(laughs) Yeah. That's it. Yup.
JW	(papers rustling). So, let's see I need to make photocopies of these. (She exits).
	(sound of a copier in the back ground)
JW	Yeah the issue is with the report. I don't know Like, we don't have it at the station.

EA	Yeah
JW	UmDo you know like, what happened to it by any chance? If somebody brought it home or?
EA	I don't know.
JW	I'm not looking to bust anybody's chops or anything
EA	I have no idea. But there was a lot of speculation over the years. (laughs).

EA	I know Since I went into the restaurant business, they've been busting my butt So I didn't get anything

EA	That was way above my pay grade. I was a rather inexperienced police officer investigating a scene that was you know, rather significant

EA	And I did what I could and thenmade my report and then, as Sgt. (inaudible) simply signed off. The only thing I didn't sign off on is my assumption that the vehicle hit the victim in the middle of Bellevue Avenue. As opposed to how, in actuality he had been driven through the gate and that's probably where he rolled off the hood. And that's what I observed on the street.

EA	So that was the signoff on that. Other than that, what I observed at the scene – I say Doris Duke now – back then I had no idea. I didn't know who she was
JW	Right
EA	She was behind the driver's – she was in the driver's seat, bleeding from the forehead, visibly emotionally upset. And that was it. So if the young paperboy says that she was outside the car with no visible injuries, that's not for me to (say).
JW	Did it look like an injury from the looks of it, that she had

	Do you remember talking to him?
EA	I don't, but he had obviously must have called the incident in. Maybe he'd stopped after observing what he did and was there when I got there. 18:04 I can't recall.

EA	The biggest thing I remember is the position she was in the vehicle and me making this stupid statement about, "He's under the car."
JW	(laughs)
EA	Which only put her in further distress.
JW	(rustling papers) So this part here Louise (she mispronounces Louis Thom, Judith the Ensign's father, as Louise) reading this statement from EA's report:
	STATEMENT OF LOUIS THOM who was bleeding st Milwaukee Wis. " I stopped to help the woman who was bleeding from the mouth. She kept yelling for somene named Ed. She then went up the drive- way and into the house and shobtly therafter came out saying she had run over him."
EA	If I took that statement I have no recollection of it.
JW	It says, "Officer Angel Reports:"
EA	OK If you refresh my recollection and if there's a lot of incorrect spelling, it certainly is my report.

EA	Well you should. I got married very young. Didn't have a lot of education. (But) I think I did a good job as a police officer, outside of my report writing.

EA	What preceded that(He seems to be reading his statement) I must have gotten this information maybe one of the other police officers on the scene had informed me because I don't have any recollection of where she went or that particular – I obviously wrote it down, so I must have been given that information by somebody, but

EA	It could well have been. All I know is, I was so involved with the seriousness of the accident that I was dealing with

I can't remember. I don't think Al was on the job then Conti.
No. I don't think so. I don't think he was.
(referring to something) I'm just double checking this before (perhaps EA's file because he seems to refer to it next)

² Another example of how, Det. Wuest has not read *Homicide At Rough Point,* the book, which not only details Norman Mather's background and involvement at the scene of Eduardo's death, but his interaction later at The Newport PD when Sgt. Don Bergeron ripped his report out of his typewriter on the orders of Chief Joseph Radice. ³ Watterson is cited multiple times in the book. Not only did he briefly interview Doris Duke at Newport Hospital where he described her minor cuts as "steering wheel injuries" but he found Eduardo's ID on the body at the crash site which helped to identify him immediately. Patrolman Watterson is also cited at the bottom of page 2 of Edward Angel's police report which Det. Wuest keeps referring to.

And he asked me – pointed out to me the gate information and his theory was on it and asked me to sign off – mainly on the point of impact. That was the big discrepancy. ⁵
	And, you know, he showed me the scene, showed me how the gates only opened inward and what his theory was and I immediately made that little statement and signed it. ⁶
JW	Do you remember what his theory was?
EA	His theory was that he (Eduardo) got out. He was driving. They approached the gates, stopped (referring to one of the diagrams)say about here.
JW	Where it says "A."
EA	The driver got out of the car and went to open the gates. And Doris Duke, slid over, hit the shifter, which was on the steering column
JW	OK.
EA	and either intentionally, or accidentally stepped on gas and hit the victim, who went through the gates where he was on the hood and he went off the hood and she ran him over and she hit the tree. That was his theory. Whether it was an accident or intentional has always been a bone of contention.

⁴ Again, not having even read Chapters 32-33 she doesn't know about Mather's account of being prevented from filling out a report and his confrontation the next day with Chief Radice. Further, she missed EA's interaction with Sgt. Newton that same day which is detailed in the book and goes directly to his "up on the hood" theory. ⁵ According to what Sgt. Newton told EA, there were actually two (2) POI's, the point where ET was struck inside

the gates and went up on the hood of the Dodge Polara wagon and the point, on Bellevue Avenue, after he rolled off and Doris Duke intentionally drove over him where EA found the skin & blood.

⁶ EA's statement wasn't dated and entered into the official report until 10.21.66, two weeks after Tirella's death.

⁷ EA's account to Det. Wuest here is a much less precise account of Sgt. Newton's theory which he told me in recorded interviews and I put in the book after I had read him the text and he approved it:

Later, after the two Rescue wagons arrived and Newport's truck extricated the body, Angel, who had been on the job less than a year at that point, pulled out a pad and pen, and started to make a sketch of the scene.

"I walked into Bellevue, looked down and I saw some skin and blood," he said. "I drew a diagram of what I thought had been the point of impact between the subject and the vehicle -- where I thought he'd been run over."

Not sure, at that point, who Tirella was or his relation to the woman he now realized was Doris Duke, patrolman Angel's first thought was that she might have hit a pedestrian crossing the Avenue after she'd gone through the gates.

"I submitted my findings," he recalled, "and the next day, before I was to go back on duty, I got called in by Sergeant Newton, who'd been my training officer. He took me back up to the scene and explained to me how the gates, which normally opened inward, had been pushed out. He showed me markings on the gates that suggested somebody had been forced up on the hood of the car. Then he walked me back into Bellevue, explaining that the blood and the skin that I'd found was from when the body rolled off and fell in front of the car. At that point it was rolled over..." End Note: 879

I'd been conducting the interview with retired officer Angel over the phone and I wasn't sure I'd heard him correctly.

"Are you telling me that Fred Newton thought that Eduardo Tirella went up on the hood of the wagon *before* it hit the gate?" Angel was quick to respond. "That's what he told me. That was his theory of the crash, and that at some point after the gates blew open, she hesitated and tapped the brakes and he rolled off. At that point he was run over by the vehicle and dragged to the point where he was still underneath it when it hit the tree."

⁹ EA did not enter the estate on the night of the homicide because he was working traffic and later did a drawing of what he saw on the street. On Saturday when Sgt. Newton took him up to Rough Point, the gravel driveway had already been graded and the tire marks were gone. However, they were photographed at 6:30 am by Robert Aughey Sr. who arrived with his son Robert Jr., just as the sun came up and before the driveway was regraded. I quote his sworn testimony about finding tire-wide "gouges marks" in the gravel an inch and a half to two inches deep. So by the time EA arrived with Sgt Newton, those "gouge marks" had been removed by Duke's staff. ¹⁰ Two admissions by JW as to Bob's credibility.
